Subject: Scheduling of Management Committee Meetings

Sir,

I am directed to state that the Management Committee meetings should henceforth be scheduled by DGH as the Chairman of the Management Committee. Meetings should be scheduled after nodal officers are ready with the technical examination being carried out for the block. Once all the agenda points have been internally deliberated within DGH, a date can be fixed for the Management Committee giving notice with sufficient time in hand. The meeting notice along with agenda points can be given 10 to 15 cays in advance.

- Consultation with Exploration Division or with IFD before fixing any date for the meeting is not necessary as this would delay the process. However, Nodal Officer may brief Exploration/IFD representatives on a mutually convenient date, prior to the meeting.
- 3. From the Exploration Division and IFD, MC meetings would be attended either by MC members/invitees or Alternate members/ invitees in case MC members are preoccupied on the date and time of the meeting. The meeting would normally be conducted as per schedule unless there are circumstances which justifying postponement. In case any member/invitee absents himself from the meeting the decision will be as per Article 6.13 and 6.14 of the PSC.


