Sir(s),

I am directed to allocate PDS SKO Quota for the 1^{st} Quarter of 2024-25 to the States as per the annexure.

- 2. In view of enforcement of Model Code of Conduct States are requested to ensure, as per the condition of Election Commission of India, that:
- (i) There shall be no publicity with regard to allocation of PDS Kerosene in electronic, print, radio, internet or any other media, in any form whatsoever.
- (ii) No political functionary shall make any reference in this regard during any public speech or communication to the press or public.
- (iii) These restrictions on publicity will be applicable to all the State Governments concerned.
- (iv) The relevant provisions of Model Code of Conduct issued by Election Commission shall be strictly followed.
- (v) No new work shall be taken up afresh during MCC period.
- 3. States are also requested to ensure lifting of the entire allocation within the Quarter itself. No carry forward of unlifted quantity, if any, to the subsequent quarter would be allowed, except in case of exigencies such as natural calamities.

- 4. State Governments are to ensure that the availability of subsidized Kerosene is for distribution under Public Distribution system to the targeted beneficiaries, only for the purposes of cooking and illumination. State Governments are also to ensure that allocated Kerosene is not diverted for adulteration of petrol/diesel or for any other unintended use.
- 5. This issues with the approval of competent authority
