**TENDER NOTICE**

Subject : Annual Rate Contract for repair & maintenance of various furniture items of the Ministry of Petroleum & Natural Gas - Re

Sealed tenders are invited in two bid system (Technical & Financial Bid) for comprehensive repairing/maintenance of wooden & steel furniture items from the reputed & eligible agencies, as per list enclosed, initially for the period of one year but can be extended for further two year on the terms and conditions enumerated in the following paragraphs :-

**2 Eligibility Criteria**

**2.1 The bidder should have**

- (a) GSTIN Number (a self attested copy of GSTIN Number Registration of the firm shall be enclosed along with copy of the latest challans);
- (b) PAN Number (a self attested copy of PAN No. card shall be furnished);
- (c) Copy of ITR return for the last 3 years shall be furnished;
- (d) Balance sheet & Profit & Loss accounts for the last three years shall be furnished.
- (e) Valid MCD license for the furniture work( trading license not applicable)shall be furnished.
- (f) Copy of furniture work experience with Govt. Deptt. for the last five years shall be furnished.
- (g) Copy of satisfactory performance of amc of furniture works only of rupees twenty lacs.
- (h) Copy of valid Bank solvency of Twenty lacs shall be furnished.
- (i) Copy of valid ISO certificates

2.2. The bidder should 05 years experience strictly in the field of 'repair and maintenance of furniture items' in the government departments/ministries. Experience relating to supply of new furniture items and any other experience will not be counted. Certificate duly issued by competent authorities in the government to be annexed.

2.3 A satisfactory performance report from the Govt. Department for the last five years contract shall also be enclosed.

2.4. The firm should have annual turnover of Rs.70 lakhs during the last three years. A Balance Sheet duly audited and certified by Chartered Accountant towards proof of average annual turnover and Income Tax Returns for the last three financial years shall be enclosed.



- 2.5 Undertaking on affidavit from the Agency that it has not been barred or blacklisted by any of the Central/state Government/ Departments/ Organizations/Central PSU and no criminal case is pending/filed against the said firm..

### 3. Sealing and Marking of Bids

- 3.1 The bidder shall place the three separate envelopes (called inner envelopes) marked "Technical Bid", "Financial Bid" and "Earnest Money Deposit" in one outer envelope. The inner envelopes will have marking as follows:-

- A) Earnest Money Deposit (EMD)
- B) Technical Bid
- C) Financial Bid

- 3.2 The sealed inner and outer envelopes containing the technical and financial bid shall be addressed to **"The Under Secretary, Ministry of Petroleum & Natural Gas, Shastri Bhawan, New Delhi.**

- 3.3 The sealed tender shall bear the name and address of the bidder on the cover of the Envelopes.

### 4. Bid Submission:

- 4.1 The envelope containing "Technical Bid" shall comprise of documents indicated in Para-2. In the absence of insufficient supporting documents, technical bid shall be rejected.
- 4.2 The envelope containing Financial Bid shall comprise of the price bids of the items as per Annexure-I
- 4.3 Each page of the Technical Bid & Financial Bid must be signed by the authorized signatory of the firm/bidder.

### 5 Financial bid

- 5.1 The financial bids of only those bidders which qualify the initial eligibility criteria will be opened for which date and time shall be intimated separately.
- 5.2 The bidder shall quote unit item rates in Indian rupees (INR), both in words and figures exclusive of taxes. In case of difference between the rates of items written in figures and in words, the rates of items written in words shall be taken as correct. No changes in unit rates shall be allowed. Applicable taxes, if any, should be mentioned separately.
- 5.3 The rates of successful bidder will be valid for 36 months from the date of award of work. During the period of contract, the rates will not be revised on any pretext. The prospective contractor may quote the rates accordingly taking into consideration of this aspect.
- 5.4 Incomplete/partial bid will not be entertained and shall be liable to be rejected.



5. Quoting of Unreasonable rates in tender viz., free of cost, complimentary, etc., shall not entertained and such tenders is liable to be rejected without giving information to the tenderer.

**6. Earnest Money Deposit (Bid Security):**

- 6.1 The Earnest Money Deposit (EMD) of Rs.200000/- (Rupees Two lakh only) must be attached. The Earnest money shall be accepted with a minimum validity of 6 months in the following forms and shall be in favour of "DDO, Ministry of Petroleum & Natural Gas, New Delhi" as Demand draft / Bankers cheques/ Fixed deposit receipt (FDR).
- 6.2 Tenders with no earnest money deposit will be summarily rejected. In case of successful bidder of the financial bids, the earnest money may be retained and adjusted towards a part of the Performance Guarantee. In the case of unsuccessful bidders, the Earnest Money Deposit will be returned without any interest.

**7. General:**

- 7.1 The firm shall provide/depute an EXCLUSIVE good skilled two carpenter well versed with the work of repair/maintenance of furniture in the Ministry of Petroleum & Natural Gas, Shastri Bhawan on all working days from 9.00 a.m to 6.00 p.m. and even on holidays or as and when required, as per the requirement of the Ministry. It is also the responsibility of the firm that the police verification of the person, so deputed, must be got done beforehand and provided to this Ministry.
- 7.2 The bidders are cautioned that supply for incomplete information called for in the application forms or deliberate suppression of any information may result in the bid being summarily disqualified. Bids received after the expiry of the stipulated date and time mentioned in the tender document will not be entertained.
- 7.3 Overwriting should be avoided. Correction, if any, should be made by neatly crossing out, initialing with date and rewriting. Pages of the eligibility criteria document are to be numbered. Additional sheets, if any added by the bidder, should also be numbered. .
- 7.3 Supply/work execution completion time will be 24 hours after receipt of the work order. In case the complaint/work is not executed on time, the Ministry will be free to get the work done through alternatives sources and the cost incurred on the same shall be recovered from the firm.
- 7.5 In event of any dispute related to above, the decision of the competent authority of the Ministry shall be final and will be binding..
- 7.6. Income tax, Works Contract Tax and any other tax at the rates in force during the progress of contract that will be in force from time to time shall be recovered / deducted from the released payment amount.
- 7.7. The Ministry reserves the right to terminate the contract without assigning any reason by giving the contractor one calendar month notice of its intention to do so.



**8 Performance Security:**

- 8.1 The Performance Security of Rs.300000/- (three Lac) will be deposited by the successful firm within the 07 days of the award of Contract. The Performance Guarantee shall be accepted in the form of Fixed deposit receipt (FDR) of a nationalized bank in favour of "DDO , Ministry of Petroleum & Natural Gas, Shastri Bhawan, New Delhi (valid upto two months beyond the time period of contract).
- 8.2 In case of non submission of Performance Guarantee along with the Agreement within specified time, the earnest money will be forfeited and the Ministry may consider to debar/black list the successful bidder in future.
9. The last date of submission of tenders is 27.01.2020 by 11:00 A.M. Tenders received after the stipulated date and time shall not be entertained. The technical bids will be opened at 11:00 A.M. on the same day i.e. 27.01.2020 in Room No.215-B Wing, 2<sup>nd</sup> Floor, Shastri Bhawan, New Delhi. Financial bids of only those bidders shall be opened who meet the technical criteria of the tender, the notice of which will be issued accordingly.
