NOTIFICATION

New Delhi, the 19th April, 2012

S.O. 850(E)—In exercise of the powers conferred by sub-section (4) of Section 15 of the Oil Industry (Development) Act, 1974 (47 of 1974), read with Section 5A of the Central Excise Act, 1944 (1 of 1944), and in supersession of the notification of the Government of India to the Ministry of Petroleum and Natural Gas, number S.O. 262(1), dated 26th February, 2006, except as respects things done or omitted to be done before such supersession, the Central Government, by being satisfied that it is necessary in the public interest so to do, hereby exempts the duty of excise on crude oil production from the fields under the Production Sharing Contracts as mentioned in the column (2) of the Table below to the extent of three thousand six hundred rupees per tonne as against the rate of duty of excise of four thousand five hundred rupees per tonne as specified vide notification of the Government of India to the Ministry of Petroleum and Natural Gas number S.O. 165(1) dated 19th April, 2012.
