The Government of India in the Ministry of Petroleum & Natural Gas has constituted the Search Committee for the purposes of selecting Chairperson and other Members of the Petroleum & Natural Gas Regulatory Board (PNGRB) and for preparing a panel of persons for appointment as the Technical Member (Petroleum & Natural Gas) of the Appellate Tribunal, under sub-section (2) of Section (4) of the Petroleum & Natural Gas Regulatory Board Act, 2006.

2. Nominations are hereby invited for consideration of the Search Committee for selection of Chairperson and 3 Members of the PNGRB and Technical Member (P&NG) of the Appellate Tribunal. Interested persons themselves may also apply. This advertisement does not cover the selection of Member (Legal) of the PNGRB.

3. The Chairperson and Members of the PNGRB would be entitled to a monthly salary of Rs.26,000 (fixed) and a salary in the pay scale of Rs.22,400-525-24,500 respectively. The Technical Member (P&NG) in the Appellate Tribunal would be entitled to a monthly salary of Rs.26,000 (fixed).
