CIRCULAR

SUB :

Filling-up of the vacant posts in the Jammu and Srinagar Benches of Central Administrative Tribunal on deputation basis- reg.

It is proposed to fill up the following posts in the Central Administrative Tribunal on deputation basis initially for a period of three years which is likely to be extended or curtailed in administrative exigencies from amongst the serving Govt. servants. The pay and allowances and other terms of deputation of the officers/officials selected for the said posts will be regulated in accordance with the instructions contained in the Department of Personnel & Training OM No. 6/8/2009-Estt.(Pay-II) dated 17.06.2010 as amended from time to time. The employees of Central Administrative Tribunal are eligible for and may continue to retain General Pool Residential Accommodation as per extant rules. The name and number of posts, classification, place of posting, tenure, scale of pay and eligibility criteria for filling-up of these posts on deputation basis are as under:-
