Subject: Ad-hoc Allocation of Public Distribution System (PDS) Superior Kerosene Oil (SKO) for the 1st Quarter of 2025-26 (April - June, 2025).

Sir/Madam,

I am directed to make an adhoc allocation of PDS SKO for cooking & illumination (lighting) and also for special needs (fisheries, mela, exhibitions, pandemic, calamity etc.) for 1^{st} Quarter of 2025-26 to the States as per the annexure.

- 2. It is to further state that States will have the liberty to sub- allocate PDS SKO for cooking and lighting or for special needs (fisheries, mela, exhibitions, pandemic, calamity etc.) based on their specific requirements. PDS SKO for cooking and illumination (lighting) purposes will continue to be distributed through Public Distribution System. Scale and criteria of distribution will continue to be decided by the respective States. Further, the present system of distribution of PDS SKO for purposes other than cooking and lighting in states may continue. State Governments are also to ensure that allocated PDS SKO is not diverted for adulteration of petrol/diesel or for any other unintended use.
- 3. States may ensure lifting of the entire quarterly allocation within the quarter itself. No carry forward of unlifted quantity, if any, to the subsequent quarter would be allowed except in case of exigencies such as natural calamities.
- 4. There will be no change in existing pricing and distribution mechanism.
- 5. This issues with the approval of the competent authority
