Subject: **Allocation of Kerosene for distribution under the Public Distribution System (PDS) for the 1st Quarter of 2014-15 (April to June, 2014).**

Sir,

I am directed to release allocation of PDS SKO for the 1st Quarter of 2014-15 (April to June, 2014) to all States/UTs as per the Annexure. Allocation for the UT of Lakshadweep has been made for the entire year of 2014-15 and the same may be lifted by the UT Administration at their convenience.

2. States/UTs are requested to ensure lifting of the entire allocation within the month itself as per the upliftment schedule communicated earlier. No carry forward of unlifted quantity, if any, to subsequent month(s) would be allowed, except in case of exigencies such as natural calamities.

3. State Governments/UT Administrations are requested to ensure availability of subsidized Kerosene meant for distribution under Public Distribution System to the targeted beneficiaries only for the purposes of cooking and illumination. They are also requested to ensure that Kerosene is not diverted for adulteration of petrol/diesel or for any other use.

4. While releasing Quarterly PDS SKO allocations to the States/UTs, this Ministry has been requesting States/UTs to furnish progress report on weeding out of multiple/ghost/bogus LPG connections. The requisite report has not yet been received in respect of your State/UT. The same may please be furnished to this Ministry urgently, if not furnished so far.

Allocation for J&K State (other than Laddakh region) is given in two blocks i.e. summer (April – September) @ 40% of annual allocation and winter (October – March) @ 60% of annual allocation. This allocation is for other than Laddakh region of J&K State. For Laddakh region State Government of J&K is allowed to uplift the entire year's allocation i.e. 4626 KL (3600 MTs) of SKO during any time of 2014-15.

\$ Allocation for Lakshadweep is 1008 KL for full financial year i.e. for 2014-15.
