
I am directed to allocate PDS SKO Quota for the 2nd Quarter of 2018-19 to the States/UTs as per the annexure.

2. States/UTs are requested to ensure lifting of the entire allocation within the Quarter itself. No carry forward of unlifted quantity, if any, to the subsequent quarter would be allowed, except in case of exigencies such as natural calamities.

3. State Governments/UT Administrations are to ensure that availability of subsidized Kerosene is for distribution under Public Distribution system to the targeted beneficiaries, only for the purposes of cooking and illumination. State Governments/UT administrations are also to ensure that allocated Kerosene is not diverted for adulteration of petrol/diesel or for any other unintended use.
