Subject: Revision in Domestic LPG Distributors' Commission

Sir/Madam,

The Domestic LPG Distributors' Commission for 14.2 kg cylinder and 5.0 kg cylinder was last fixed at Rs. 50.58 per 14.2 kg cylinder (Establishment charges: Rs. 30.08 and delivery charges: Rs. 20.50) and Rs. 25.29 per 5.0 kg cylinder (Establishment charges: Rs.15.04 and delivery charges: Rs. 10.25) vide this Ministry's letter No.P-20028/1/2001-PP (Pt. II A) dated 6th November, 2018. Customers who collect their refills directly from Distributor's premises are not being charged the delivery charges and are entitled to get the cash and carry rebate irrespective of category and distributorship.

- 2. After careful consideration of the recommendations of *de-novo* study for revision in LPG Distributors' Commission conducted by IIM, Ahmedabad in consultation with PPAC, it has been decided to revise the Distributors' Commission to Rs. 61.84 per 14.2 kg cylinder (Establishment charges: Rs. 34.24 and Delivery charges: Rs. 27.60) and Rs. 30.92 per 5 kg cylinder (Establishment charges: Rs. 17.12 and Delivery charges: Rs. 13.80) with following timelines: -
- (a) 1st August, 2019 50% increase (i.e. ₹ 5.62 for 14.2 kg cylinder)
- (b) 1st September, 2019 25% increase (i.e. ₹ 2.82/- for 14.2 kg cylinder)
- (c) 1st October, 2019 25% increase (i.e. ₹ 2.82/- for 14.2 kg cylinder)
- 3. As regards 5 kg cylinders, the revised distributors commission will increase in line with the time line and percentage mentioned at para 2.
- 4. Remuneration to the distributors, which forms part of the commission should be linked to performance of the distributor and OMCs may work out the norms.

- 5. It is clarified that the distributor's commission arising out of *de-novo* study will subsume the proposed annual revision for this year and future annual revision will be based on the proposed formula in the Report.
- 6. Kindly acknowledge receipt of the letter.
