2. Sealed quotations are invited for the disposal of said vehicle on the terms and conditions mentioned below. The interested parties may submit their quotation in the enclosed Proforma. The quotations addressed to the undersigned in a sealed cover should reach the Ministry latest by **11.00 A.M. on 26.08.2016**. The quotations received in time will be opened at 12.00 Noon on the same day i.e. **26.08.2016**. Bidders wishing to submit their tender by hand may drop the same in the Tender Box kept at Facilitation Counter of Ministry. The cover should be prominently super scribed with the words "QUOTATIONS FOR PURCHASE OF CONDEMNED VEHICLE". The vehicle can be inspected between **03.00 pm to 05.00 pm on 23.08.2016 & 24.08.2016**.

3. The quotations received in time will be opened in Room no. 311(A) A wing, Shastri Bhawan, New Delhi by the Tender Committee. The bidders or their representative (not more than one) may be present, if they so desire, at the time of opening of quotations alongwith an authorization letter from the firm.

4. The sale will be governed by the following **terms and conditions:-**

- (i) The bidder is required to pay an earnest money deposit (EMD) of **Rs.3,000/-** for the vehicle, which shall be payable by means of demand draft drawn in favor of **DDO, Ministry of Petroleum & Natural Gas** payable at New Delhi. Quotations received without EMD will not be considered and shall be rejected summarily.
- (ii) The successful bidder will be required to deposit the bid amount by means of cash/demand draft drawn in favor of **DDO, Ministry of Petroleum & Natural Gas** within two working days of the acceptance of the bid by the Ministry.
- (iii) The EMD of the successful bidder will be released only after the deposit of sale proceeds. **EMD will be forfeited if the bidder fails to honour the bid.**

- (iv) The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status viz. Ration Card/Voter Identity Card/Passport in case of individual and registration certificate in case of firms etc.
- (v) The sold vehicle will be removed by the successful bidder at their own expenses from the premises of the Ministry within two days of depositing the money.
- (vi) The vehicle will be disposed off on "As is where is basis" and no guarantee for its worthiness or quality will be given by this Ministry.
- (vii) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. The Ministry will not be responsible for any lapse on his part in this regard
- (viii) The bidders will not be allowed to withdraw their bids, once submitted and their EMD will be forfeited.
- (ix) The undersigned reserves the right to accept or reject any/all of the quotations without assigning any reason therefore.
