Terms and conditions for award of Annual Rate Contract (ARC) for making of rubber stamps, name plate, banner etc. for the Ministry of Petroleum and Natural Gas, Dr. Rajendra Prasad Road, Shastri Bhawan, New Delhi

- 1. The tenderer should be a reputed supplier having sufficient experience in Government Offices (at last 03 years) and expertise in the relevant field as also having sound financial standing i.e. last 02 years' annual turnover should be more than 02 Lakh. Copies of experience certificates from at least 03 Central Governments Ministries/ Departments, Annual Account statement/balance sheet for the last 02 years etc. should be enclosed with the bid. Bid validity period may also be mentioned along with quotation.
- 2. The tenderer should have a well established office located within a radius of 15 Km. from Shastri Bhawan and a person should be available on all working days between 09.00 a.m. to 05.30 p.m. on call of the Ministry.
- 3. The tenderer should provide the name and telephone/mobile number of person, who can be contacted at any time, even beyond office hours and on holidays. The tenderer should be capable to arrange the supply of ordered items, even at a short notice.
- 4. The office will have the authority to place orders for supply of items beyond office hours and on holiday, for which, no additional payment will be made.
- 5. No separate charges shall be paid for delivery of goods to the premises of Ministry of Petroleum & Natural Gas, Shastri Bhawan or any place in NCT of Delhi as desired by the Ministry.
- 6. The tenderer should enclose a signed copy of the terms and conditions stipulated for award of the contract, conveying his acceptance of the same.
- 7. The rate should be quoted in order of articles mentioned in annexure-"A" to this tender notice and submit along with a Demand Draft of Rs.2000/- (Rupees Two Thousand Only) drawn in favour of "D.D.O., Ministry of Petroleum and Natural Gas, New Delhi" as EMD. The EMD will be returned after finalization of the contract. Any tender that is received without the EMD money will be rejected outright. EMD will be forfeited, in case any firm desires to withdraw their bid, after its receipt in the Ministry.
- 8. Tenders incomplete in any form or received unsealed are liable to be rejected outright and in toto. Terms and conditions that any tenderer wishes to specify should be clearly stated in the bid itself.

- 9. Sealed Tender complete in all respects should be dropped in the tender box placed near the Gate No. 3, Facilitation Center, Garage No. 18, Ground Floor, Ministry of Petroleum and Natural Gas, Shastri Bhawan, New Delhi by 03.00 PM on 11th March, 2016. The tenders received will be opened at 04.00 PM on the same day. The tenderer, if they so desire, may depute their representative to be present at the time of opening the tenders.
- 10. This Ministry will have full authority to reject any/all offers without any reason thereof. Any enquiry after submission of the quotation will not be entertained.
- 11. The time limit given by the Ministry to the contractor must be adhered to invariably, in all jobs, irrespective of the quantity or quality ordered.
- 12. The rates will include all charges together with the supply costs in the premises of Ministry of Petroleum and Natural Gas at Shastri Bhawan and the residence of higher officers in Delhi/New Delhi, if so required.
- 13. The Ministry reserves the right to terminate the contract at any point of time if the services are not found to be satisfactory. The decision of the competent authority of the Ministry of Petroleum & Natural Gas will be the final in this regard.
- 14. The successful contractor has to replace and make good of any damaged or defective work at his own cost within reasonable time as decided by the Ministry of Petroleum and Natural Gas.
- 15. A copy of TIN No./VAT No./PAN No. may also be enclosed with the quotation.
- 16. The successful tenderer will have to deposit a security deposit of an amount of Rs.5000/- (Rupees Five Thousand only) as Performance Security drawn in favour of "D.D.O., Ministry of Petroleum and Natural Gas, New Delhi", valid for a period of 60 days more that the period of contract or the extended period of contract as the case may be. The performance security will be returned after successful expiry of contract. The Ministry will not pay any kind of interest for the said period. The performance security of Rs.5000/- will be forfeited if the firms does not provide satisfactory service and the decision of Dir.(Admin)/ DS(Admin) will be final in this regard.
