2. Sealed quotations are invited for the disposal of said vehicle on the terms and conditions mentioned below. The interested parties may submit their quotation in the enclosed Proforma addressed to Under Secretary (Admn), Ministry of Petroleum and Natural Gas, Shastri Bhawan, New Delhi- 110001. The tender should be drop in the tender box kept at Facilitation Center, Garage No. 18, Ground Floor, Shastri Bhawan, New Delhi. Quotation received through other mode of correspondence will not be entertained.
3. The quotation should reach the Ministry latest by **03.00 P.M. on 27.07.2017**. Tender received after the stipulated date and time shall not be entertained. The tender will be opened at **04.30 A.M on the same day i.e. 27.07.2017**. The cover of envelop should be prominently super scribed with the words "QUOTATIONS FOR PURCHASE OF CONDEMNED VEHICLE". The vehicle can be inspected between **03.00 pm to 05.30 pm on 26.07.2017**.
4. The quotations received in time will be opened in Room no. 207, "B" wing, Shastri Bhawan, New Delhi by the Tender Committee. The bidders or their representative (not more than one) may be present, if they so desire, at the time of opening of quotations alongwith an authorization letter from the firm.
5. The sale will be governed by the following **terms and conditions:-**
 - (i) The bidder is required to pay bid security (EMD) of **Rs.5,000/-** for the vehicle, which shall be payable by means of demand draft drawn in favor of **DDO, Ministry of Petroleum & Natural Gas**.
 - (ii) Quotations received without demand draft towards earnest money will not be considered and shall be rejected summarily.
 - (iii) The successful bidder will be required to deposit the bid amount by means of cash/demand draft drawn in favor of **DDO, Ministry of Petroleum & Natural Gas** within two working days of the acceptance of the bid.
 - (iv) The earnest money of the successful bidder will be released only after the deposit of sale proceeds and transfer of vehicle in the name of bidder. **Earnest money will be forfeited if the bidder fails to honor the bid.**

- (v) The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status viz. Ration Card/Voter Identity Card/Passport in case of individual and registration certificate in case of firms etc.
- (vi) The sold vehicle will be removed by the successful bidder at their own expenses from the premises of the Ministry within two days of depositing the money.
- (vii) The vehicle will be disposed off on "As is where basis is" and no guarantee for its worthiness or quality will be given by this Ministry.
- (viii) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. The Ministry will not be responsible for any lapse on his part in this regard
- (ix) The bidders will not be allowed to withdraw their bids, and their earnest money will be forfeited.
- (x) The Ministry reserves the right to accept or reject any/all of the quotations without assigning any reason therefore.
